#### How do I enter?

Entries must be summitted using the online form, which you can access here.

#### What is the deadline for entry?

The deadline for submissions is 6pm PDT Friday 11th August 2023.

#### My project was conducted globally, can I still enter?

Any appropriate project conducted in North America, South America or Asia-Pacific is eligible for entry in the EHS Innovation Excellence Awards Americas. Global projects led by teams in these regions are also eligible. Projects conducted in other regions should instead be entered into our EHS Innovation Awards EMEA 2024.

#### Do you have examples of winning entries?

Winning entries are those that demonstrate real innovative thinking and tangible benefits. We encourage the inclusion of project details relating to the challenge, solution and results achieved. View a winners case study here.

#### How many words should I write?

We encourage the use of succinct entries, which clearly demonstrate the project's challenge, benefits and achievements, and other information that will provide further understanding to the judges. Bullet points are fine to include.

#### Can I submit more than one entry?

We advise against entering for more than one award. When selecting finalists, the judges will limit to one entry per corporate company or technology vendor.

#### When are the awards held?

The awards will be held on the evening of Tuesday 17th October as part of the Verdantix EHS Summit Americas 2023, which you can register to attend here.

#### Can I attend the awards ceremony?

### • I'm a technology vendor or services provider, am I allowed to enter?
